STRATEGIC PLANNING

Over the course of the last sixteen years, my principal area of specialization has been strategic planning for Fort Hood Garrison, Headquarters, United States Coast Guard, Federal Transit Administration, the Transportation Security Administration, and the Installation Management Agency, United States Army. Responsibilities included: development of business plans, strategic goals and objectives, performance measurement plans, and performance reports. Our efforts resulted in significant improvements in all areas, with the **most notable being the presentation of the Texas Quality Award to the Fort Hood Installation in 2000.**

PERFORMANCE MEASUREMENT

Establishment of realistic performance measures and standards is an integral part of the strategic planning process. While assigned to the Coast Guard Headquarters, and tasked to develop five essential criteria for Coast Guard training program evaluation, my efforts resulted in a **15 percent increase** in individual proficiency as measured by Skill Qualification Testing, while concurrently **reducing course costs by 25 percent, a net saving of 8.4 million dollars per annum**.

BALDRIGE CRITERIA

Following certification as a Baldrige examiner, I used this expertise as a member of the Coast Guard team to evaluate organizations under seven key criteria. Use of these criteria enabled the examiners to objectively evaluate all applicants, with the finalist receiving the coveted Commandants Quality Award, symbolic of true organizational excellence. Following the 2001 review, best practices were shared throughout the command, providing impetus for wider adoption of more efficient business processes.

The winning applicant's logistics management process, when adopted throughout the Coast Guard, resulted in a 19 percent reduction in spare parts inventory, saving the command approximately 78 million dollars annually, which resulted in 4 previously unfinanced requirements being funded with year end "savings".

QUALITY MANAGEMENT

Working as a certified TQM facilitator, provided three courses of classroom instruction to various subordinate command elements. This "train the trainer" instruction, in conjunction with orientation sessions and a managerial overview, enabled TQM skills to be implemented throughout the organization. This TQM marketing effort enhanced the organization's ability to identify best practices that would otherwise have been ignored, concurrently focusing attention on inefficiencies, subject to corrective action on the part of the organization.
