The seven WWII Veterans (all in their 90's) are native New Hampshire women who, when their country needed them the most, stood up and joined the military during a time of war. They were among the very first women in the United States to do so and forged the way for many generations of women to come. Their service shattered many of the gender and equality biases of their time. These ladies served in every branch of the service including the U.S. Army (USA), the U.S. Marine Corps (USMC), the U.S. Army Air Forces (USAAF), and one would later retire from the U.S. Coast Guard. The honorees included Private First Class Olga Currier, USMC, of Weare; Pharmacists Mate 1st Class Isabel Dabrowski, USN, of Manchester; Corporal Emilia De-

How You Get Medicine Is About To Change

TRICARE beneficiaries will be required to refill select maintenance medications through TRICARE Pharmacy Home Delivery or at a military pharmacy - or pay the full price at retail - beginning Oct. 1.

The FY15 defense bill expanded the pilot to encompass all TRI-CARE beneficiaries, with the exception of those on active duty, those with other health insurance that provide drug coverage, or those who live overseas. While active duty service-members are exempt from the mandate, active duty family members will be required to participate in the program.

In September, beneficiaries will receive a notification letter from TRICARE providing details on enrollment instructions and the waiver process. Beneficiaries can still get short-term or "acute" drugs from retail pharmacies like antibiotics and pain medications. The new mandate only applies to select main-tenance medications, many of which are brand name.

Unlike the original pilot, there will be no ability to "opt out" of the program after one year. Starting Oct. 1, beneficiaries will have approximately 90 days to move their prescriptions before being responsible for 100 percent of the cost share.

For years, MOAA has said that home delivery is a low cost, safe, and convenient option for beneficiaries to fill their maintenance drugs and save money.

CHAPTER DUES INCREASE

After careful consideration, the Board of Directors has recommended that the chapter increase the annual dues rate for regular members from \$15.00 to \$19.00 effective January 1, 2016. It is planned to propose the increase at the annual meeting on November 7, 2015. This recommendation must be voted on by the chapter membership at a regular meeting, in accordance with the chapter by-laws. At the present time, the Board has decided not to recommend raising the annual dues (of \$10.00) for auxiliary (widows) members.

The chapter has not increased its regular member dues since 2001, yet the cost of printing and mailing has gone up steadily. As the chapter has lost money for the past several years, the Board felt it was time to raise the dues this modest amount.

The Board is also considering raising the Life Membership dues rates for regular members to reflect the new annual dues rates.
