

By the time you read this, Thanksgiving will have come and gone; and I trust that

everyone enjoyed that most traditional of our holidays with family and friends. I wish to take a few moments of your reading time to thank Bob Jaffin for his two years at the helm of the chapter. Bob did a commendable job under most difficult circumstances, and he should be thanked and praised by all of us. Kudos for a job well done, Sir.

As we approach 2022, our chapter is in good shape, although we face many challenges in the years to come. Let me take a few minutes to recap some of those challenges for folks who were unable to attend the Annual November 2021 Meeting in Nashua. Possibly our most significant challenge is demographic, as in approximately 11 years, our chapter has lost approximately 600 members, falling from approximately 1,200 to 600 today. As Pete Burdett routinely reminds us, "We are All Recruiters" for the chapter; and I am confident that we can reverse this trend. Most of us know people who served some time as Commissioned Officers, even if they did not retire from their respective services. Ask them to consider joining the chapter and be able to sell the benefits of membership to them.

Another challenge we face is maintaining essential chapter staff positions at full strength. Recently, we recruited two members to fill Roby Day's Treasurer's slot. Roby has done a masterful job and will work with Dee Fasoli and Wayne Balcom to successfully transition responsibilities and continue to assist as requested and necessary. We have also been successful in recruiting a recording secretary to reduce Michael McLean's workload. Michael's work for the chapter is often not seen by the membership, as he focuses on keeping us Five-Star eligible, often working behind the scenes. In my opinion (shared by the Board of Directors), Michael is a key element in our year in/year out success as a chapter.

Unfortunately, we have not been successful in recruiting a Public Affairs Officer or a new editor for the Granite Slate. The PAO slot has been vacant for a period; and our Granite Slate editor, Marie Chipola, will be leaving the position after the first edition of 2022. If anyone is even remotely interested in either position, please feel free to contact me or Marie for more information.

Our Events Calendar is starting to fill up. Due to circumstances beyond our control, the "Granite State Warriors Award" luncheon, normally held in late January, has been cancelled for this year. Nominations for the 2022 award cycle can be provided to Ray D'Amante, the new head of the search process for the "Warriors" award. We will be scheduling a date for an April Luncheon at the Common Man in Plymouth, NH shortly after the holiday season.

The June event will bring us back to North Conway, the home of the outlets. July's event will be a baseball

game at the home of the Manchester NH Fisher Cats. The world-famous Clambake will return to the Portsmouth Naval Shipyard in August. More information will be provided in the future.

In closing, I want to take this opportunity to thank all members of the BOD, and all the rest of the chapter for what you do for the organization - Merry Christmas and Happy Holidays.

Winnipesaukee Scenic Railroad Trip

MOAA NH was lucky enough to have President Bob Jaffin organize and connect with the Winnipesaukee Scenic Railroad Company (once dubbed the "HOBO" railroad) for a lakes region foliage tour on October 23, 2021. We were joined by over 50 MOAA-NH members and guests and provided with our own private rail car for the trip.



The train traveled a little over an hour from the Meredith, NH station through Ashland and Bridgewater before reaching the Plymouth Railroad Station (next to the Common Man Restaurant). At the Common Man, we enjoyed a delicious dinner

buffet of roast turkey with all the fixings, lasagna, beverages, and dessert. During the trip, we watched colorful foliage enhanced by bright sunshine, a farm full of Christmas trees, and a field with hundreds of deer. We also journeyed along the shoreline of Lake Waukewan. This lake provides drinking water for the entire city of Laconia, thus very few boats are allowed.

The Common Man Restaurant was familiar to many

MOAA members as we've attended events there several times during past years. On the return trip, we toured the Ashland Railroad Station Museum with members of the Ashland Historical Society greeting us in period attire.



The scenic railroad has a unique history using the NH track systems, as several owners including the State of NH joined together forming the now Winnipesaukee Scenic Railroad a number of years ago. The railroad holds the passenger rights to the entire state of New Hampshire-owned track network running from Lochmere to Lincoln, a total of 54 miles.

These rails have some of the most diverse and scenic fall foliage trains in New England, and our chapter was very fortunate to have such a wonderful day to enjoy them.

We very much appreciate President Jaffin's time spent in organizing this outing.

This year *eleven* students will receive loans, and this year the clambake raised \$3,720. Thank you to all who contributed!!

In addition to the money raised for our Chapter's Scholarship Loan fund, Chapter members donated a substantial amount of canned goods helping to support the Manchester VAMC veterans.

Slowly, the mounds of goods were whittled down; but, there is still much for her to process.
