### MOAA-NH Provides Information on Proposed Reduction in MTF Coverage

During the July meeting at the Red Blazer, a decision was made to provide the CODEL with the chapter's take and information regarding the DOD's proposal to "Descope Military Treatment facilities". Following several drafts and coordination among key members of the MOAA-NH BOD (thanks to Pete Burdett, Andrew Breuder, Bob Jaffin, Larry Miller, and others too numerous to list in this short piece), I signed a letter to all members of the NH Congressional Delegation, on August 2<sup>nd</sup>. This letter focused on the continued erosion of military retiree benefits in the crucial area of health care, and how those reductions affect both recruitment and retention of a quality force.

I am pleased to let you all know that on August 9<sup>th</sup>, the combined Congressional delegations of New Hampshire and Maine signed a letter to the Deputy Secretary of Defense, the Honorable Kathleen Hicks, discussing our concerns in some detail. The CODEL letter focused on the Portsmouth Naval Yard's clinic, and the impact that "descopeing" would have on AD military and retired personnel in the containment area of the clinic. Moreover, the delegation urgently requested a briefing from the DOD "within the next 30 days" to update the delegation on key operational issues for the PNSY outpatient clinic and allied concerns.

I and other members of the BOD will follow up with the CODEL in early September 2022 and provide more information to all MOAA members later that month. If anyone desires a copy of the CODEL letter, please let me know.

### MOAA-NH Financial State of Affairs

Our financial condition has remained stable for many years, and our balance sheet has consistently grown since December 2012 when financial reports to the membership were first presented in classic accounting formats. Our total assets in 2012 amounted to over \$278,600, and by 2021 they had grown to over \$544,000. That said, since the beginning of 2022, we have experienced a loss of about \$45,000 from total assets, but that is understandable.

The losses in 2022 to date are due primarily to the declining securities markets that will recover in time. Several factors can explain the growth between 2012 and 2021, those being securities markets growth and our own organizational activities. Our membership has consistently been generous with donations to our scholarship program, and with the self-discipline inherent in making our events pay for themselves, there has been no damage done to our treasury.

Despite our self-imposed restrictions regarding use of funds (e.g. Scholarship and Life Membership investments), unencumbered funds for defraying operating costs have always fluctuated widely, and today they stand at over \$10,000. It is significant that, since 2012, we have never had to withdraw funds from the Life Membership investments to pay for operating expenses, covering expenses entirely with current year finances. Can we sustain such financial momentum? "Only The Shadow knows."

Clearly, a continued annual net decline of 45-50 persons per year can be devastating to our chapter's future. WE ARE ALL RECRUITERS, and a copy of our membership application is included in this Granite Slate. Please feel free to print it out and use it as you talk to prospective chapter members.

As most of us are fully aware, the cost of everything is increasing, and you must expect a somewhat significant increase in the future costs of luncheons and special events with lunch included. Citing just one example, prices for a Fisher Cats special event, including set aside seating, hamburger/hot dog buffet and all the fixings was reviewed this year and deemed cost prohibitive. We are always seeking to do interesting and affordable events. If you have suggestions, please contact Gerry Boyle, Chad Chadwick or me.

Closing on a positive note, our annual meeting and luncheon is scheduled for November 5, 2022, at the Nashua Country Club. We are fortunate to have the Commander of the USS Constitution, the oldest active-duty warship in the world, as our guest speaker. ### ***DOD Next Gen USID Cards & TSA Usage***

Identification cards for service members, retirees, and their dependents have changed to the Next Generation Uniform Service Identification (USID) cards and are being issued now. Those whose cards do not have an expiration date will need to upgrade within the next four years. The USID cards provide enhanced security features that include compatibility with Transportation Security Administration (TSA) checkpoints in all U.S. airports as a REAL ID, and free [TSA Pre-Check](#) availability for currently serving service members and DOD civilians.
